DeFazio mentioned that new parks are not installing new parks with rubber mulch, they are filling with wood chips. Grace mentioned that the rubber bark is a better solution to the liability problem. Harding suggests to keep rubber mulch, then geotextile fabric followed by wood chips. Grace says that may be a possible compromise and could help with the cost of replacement.
